



Our Founder Sir Auckland Colvin K.C.S.I., K.C.M.G., C.I.E.

OUR FOUNDER



Sir Auckland Colvin, KCSI, KCMG, CIE was a British civil servant and colonial administrator who served in various high-ranking positions in Egypt and British India during the late 19th and early 20th centuries.

He was born at Calcutta on 8 March, 1838. being the third son of the ten children of John Russell Colvin, by his wife Emma Sophia. Three of his brothers, Bazett Wetenhall Colvin, Eliott Graham Colvin and Sir Walter Mytton Colvin had passed distinguished careers in India. A fourth brother, Clement Sneyd Colvin, was secretary of the Public Works Department of the India Office, in London.

Sir Auckland was born when his father was Private Secretary to George Eden, first Earl of Auckland, then Governor General of India, and was named after him. In retirement, Sir Auckland wrote the Biography of his father who rose to become the Lieutenant Governor of the North Western Provinces and died in the Mutiny of 1857.

He was educated at Eton from 1850 and from 1854 at the East India College. He married Charlotte Elizabeth Herbert on 4 August, 1859. He had a son, who died in infancy, and 4 daughters. He died on 24 March, 1908 at Suffolk House, Maple Road, Surbiton where he was living with his

eldest daughter, Emma Sophia Groome, and was laid to rest at Earl Soham, Framlingham.

Sir Auckland arrived in India on 17 January, 1858 and was posted to the Agra provinces. After serving the usual district novitiate, he returned to the headquarters in May 1864 as under secretary in the Home and afterwards in the Foreign Departments of the Government of India. He returned to his own province in July 1869 as a settlement officer and did good work in the revision of the Allahabad district settlement. He officiated as secretary to the Government of the North Western Provinces in April 1873 and from the following June as Commissioner of Excise and Stamps. The Lieutenant Governor, Sir George Couper, resented some criticism of the local government in The Pioneer (Allahabad), which was attributed to Colvin's pen, or inspiration. In the spring of 1877, Couper sent Sir Auckland back to district work as Collector of Basti. From November 1877, he officiated for a short while as Commissioner of Inland Customs under the Government of India, and was afterwards made Collector of Bijnaur.

When Lord Cromer became British Agent in Egypt, Sir Auckland succeeded him as the financial member of

the Viceroy's Council in India in August 1883. There were serious financial difficulties. The war in upper Burma had started. The danger of hostilities with Russia, consequent upon the Panjdeh Incident, were followed by great capital outlay on improving the strategic position of the North West Frontier and by increases in the British and native armies. Colvin minuted against this increase but the military component in the Viceroy's Council did not listen to him. Although he caused a committee to be appointed under Sir Charles Eliott to recommend economies, he was compelled to suspend the Famine Insurance Fund and increase the taxation. In his last budget (1887-88), he increased the salt duty by 25% and imposed an export duty on petroleum.

Sir Auckland welcomed his transfer on 21 November 1887 to Allahabad as Lieutenant Governor of the North-Western Provinces and Chief Commissioner of Oudh from 1887 to 1889, succeeding Sir Alfred Comyn Lyall. To his influence were due good water supplies and drainage systems in the larger towns of what were by then known as the United Provinces, several new hospitals and the Colvin Taluqdars' College at Lucknow. During his tenure, he made efforts to micro-manage the local administration and implement several economic and social reforms. He was also involved in dealing with the social and political challenges of the time. Colvin's contributions to British India's administration were significant, and he left quite a mark on the region during his service.

The construction of the school started early in 1881. With the introduction of the wards class in 1884, the school began to grow and was established formally in 1889. Henry George Impey Siddons became the first Principal.

Colvin recognized the importance of education and sought to improve educational opportunities in the region. He provided support and resources for the establishment of the school, which was initially intended to cater to the educational needs of the Taluqdars, who were landowners and revenue collectors in Oudh. The school was named after him to honor his contribution.

Over the years, Colvin Taluqdars' College has grown and evolved into a prestigious educational institution in Lucknow, providing contemporary education to the students.

olvin Taluqdars' College was established in 1889. It has been the vanguard of western education in Northern India. Established to provide education to the children of privilege, the College has adapted to an egalitarian society, brought about by the Independence of India in 1947. As a result, the College boasts of a tradition of nobility, blended with all that is noble in modern India.

The aristocratic privilege, once regarded as a prerequisite for admission to the College has now been replaced by merit, which is the hallmark of modern aristocracy. In keeping with its traditions and the requirement of a global world, the English language continues to be the medium of instruction. This is to ensure that the present generation is advantaged and finds itself equipped to take up international responsibilities, requiring fluency in the English language.

The general atmosphere is avowedly secular, while the belief systems of all faiths are equally respected. A cosmopolitan mixture of students from different strata of modern society provides an atmosphere of tolerance and practical awareness. This simultaneously ensures that the students learn best from each other.

The Motto of the College is *Noblesse Oblige*. This roughly translated from the original French suggests that whoever claims to be noble must conduct himself nobly. That is, a person is expected to act in a fashion that conforms to one's position, and the reputation he has earned.

The College has trained some of the finest minds in the country. Our students are represented in every walk of national life including politics, the armed forces, administration, art, entertainment, medicine, sports and the law. These representatives are spread in the different parts of the world carrying with them the values of the institution as enshrined in the College Motto.

The College welcomes the contribution of the alumni not just in material terms but through the passing on of healthy traditions to ennoble the present.



MESSAGE FROM THE PRINCIPAL



Consequently, generations after generations of students have expressed varied feelings about the way in which this school has influenced their lives. Colvin means different things to different people from different generations. As I take over the reins of the school, I find myself torn between the responsibility of systematically arranging, integrating and preserving the past traditions and recaliberating the existing processes and procedures to accommodate the scholastic and aspirational needs of the present and future generations.

For one, Colvin has no dearth of infrastructural resources. In fact, there is hardly a school in Lucknow that has half the facilities that Colvin offers. Yet, I must admit, from the little I have gathered, that there are quite a few areas in which a substantial amount of thought has to go in. Students who just need a school that is convenient and comfortable should be ready for some very demanding assignments and tasks. Teachers have to be

prepared for a round of training and upgradation since the National Curriculum Framework has to be implemented in the best interests of education.

The way forward is certainly not going to be easy. All stake-holders will have to chisel and align their mind sets with the New Education Policy in order to achieve all realistic targets in their respective domains. A lot of us will have to work out of our skins, particularly those for whom coming to school is just a matter of habit. The teaching and learning outcomes must be determined and systematically assessed, with prompt remediations thrown in, where required. Teacher and taught must make their attendance count.

Education is incomplete if a child is unable to read, infer, write in his natural voice, speak fluently and calculate; if knowledge cannot be applied in real life to raise the lot of the poor and downtrodden; if the

students leaving the portals of our school are unable to sing, play musical instruments, laugh, dance, draw, paint, debate on relevant issues and discuss ideas in an atmosphere of cordiality, it is his school that will be blamed.

We have to work not only on bodies and minds but also on the spirit. We have to weed out ideas that are incongruous with the new world and cling on to those that give us our identities. Knowledge that is confined to rextbooks is only a starting point. We have to make sure that we develop the requisite skills that will help us hold our own in the rapidly changing world. We must transform ourselves from an overly superstitious, gullible lot to reasonably scientific people who live by reason and are, eventually, an asset to society. Let us not forget that in every time and every age, we have an obligation towards society.



The iconic heritage building called 'The Main Block' has a pristine look. It accommodates the college offices, audio-visual rooms, the Principal's office, the middle and senior classes. The BP Halwasia Memorial Building, beside the approach road to the Principal's Residence, is the Computer Laboratory. A Robotics Lab is also being planned to provide practical training in Cyber Security, Coding, Drone Technology, Robotics and Electronics.

JUNIOR BLOCK









Primary and Primary Classes are held in the building to the right of the Library building. The Junior school has a Headmistress who looks after the Academic and Extra Curricular Activities. In recent times, Colvin Taluqdars' College has started admitting girl students as well and they can continue studying till Class XII. The Junior Block has an auditorium which is often used for Junior School programmes. A separate Activity Centre has also been created to develop skills in the students at an early age. There is an exclusive Library curated with books designed to interest children and inculcate the habit of reading. The Junior Block has its own computer Lab and smart classes using Tata Class Edge technology and content.

Teachers use the playway system to develop motor skills, facilitate cognitive development, social and emotional intelligence among the tiny tots. We take the best practices from diverse methodologies and try to balance the development of the left brain along with the right brain, the focus at all times being on holistic development.

CRICKET ACADEMY

The college has

The College runs a Tennis Academy with skilled and qualified coaches and has well-lit grounds. These 'A'-level professionals can train the scholars of different age groups and proficiency levels even during twilight hours according to convenient time-slots.





FULL-SIZE SWIMMING POOL

The College maintains a fully functional swimming pool. Coaches, lookouts and life guards are always at hand during the functional hours. While the pool is regularly inspected for hygiene and water quality, trainees from different age-groups and proficiency levels are trained during separate time slots.





ADMISSIONS AND ACADEMICS

Students write the Indian Certificate of Secondary Education (Year 10) Examination (ICSE) and the Indian School Certificate (Year 12) Examination (ISC) conducted by the Council for the Indian School Certificate Examinations, New Delhi (CISCE). The academics performance of the Scholars is evaluated on a regular basis. Two Unit Tests are administered to assess continuous progress. Together with Half-Yearly and Final Examinations they also form the basis for promotion to the next higher class. Students may be advised to attend Remedial Classes that are held in the College regularly. These classes are held after the school hours on working days. Summer classes are held in the mornings throughout the vacation period. These sessions are especially structured to assist the Scholars in both school syllabus and the competitive examinations.

Procedure of Admission

After purchasing this Prospectus, parents seeking admission for their children must complete the enclosed Registration Form along with two copies of Rules and Regulations that must also be completed in all respects. A signed copy of the Rules and Regulations must be submitted at the College Office on the date indicated on the form.



Age Requirements

The minimum age as on 31st March of the year of admission should be:

Playgroup : 2 Years
Nursery : 3 Years
Lower Kindergarten (LKG) : 4 Years
Upper Kindergarten (UKG) : 5 Years
Class I : 6 Years

For admission to class I and higher Classes, a Transfer Certificate is required.

ADMISSIONS AND ACADEMICS



Interview/WrittenTest/ProvisionalAdmission

Candidates seeking admissions will be interviewed and tested for preparedness for the class they seek admission to. Admission will be offered to Class XI students from other schools on the basis of their performance in the Class X Board Examinations and an interview. A written test will also be conducted. Admission to Class XI will remain provisional unless approved by the Council. Kindly note that registration does not guarantee admission.

Candidates offered admission will be required to complete all admission formalities within a week, failing to which no further



requests for admission will be entertained. The College reserves the right to offer the seat to another candidate in order to merit.

ISC/ICSE Council's Condition of Entry

Entry to the Indian School Certificate Examination/Indian Certificate of Secondary Education Examination in the case of eligible candidates, who are being entered for the first time, is restricted to candidates with the minimum of 75% attendance of the working days during each year of the two year course at school(s) affiliated to the Council and registered for the (Indian School Certificate Examination /Indian Certificate of Secondary Education Examination). The last date of computing attendance at schools is February 15 of the year of examination.

It is the responsibility of the parents/guardians to ensure that their child/ward attends classes regularly. **No student**, whose attendance is **below 75% of the working days** in the academic year may be permitted to appear for **either the half-yearly or the final examination**. **This is a Council Regulation**.



WITHDRAWALS & REFUNDS

Scholar who leaves the College in mid academic session will be required to pay his College (and Boarding) fee till the end of the academic session. All annual charges will have to be paid in full.

A transfer Certificate will not be issued until all outstanding dues have been cleared.

Refunds

No fee (Tuition or Boarding) shall be refunded.

Caution money paid to the College and Boarding House is refundable only if requested within 3 months of the student leaving the College. In case of a mid-term withdrawal, the caution money is refunded one month after the student applies for the refund. Applications for refund should be made on the proper form, available at the College Office. A 'No-Dues' certificate from various departments should be attached with the application.

The receipt of the caution money must be enclosed with the application for refund without which no refund requests will be entertained.





ATTENDANCE



- ▲ Students are expected to attend their classes regularly. Students who come late may not be allowed to attend the College that day.
- ▲ No leave of absence will be granted during the term, except under very special circumstances. The Principal's prior permission for the leave of absence from College is essential.
- All leave applications should be addressed to the Class Teacher, except for leave beyond 4 days. Such applications should be addressed to the Principal and prior permission must be obtained. The leave application of Resident Scholars is to be submitted to the House Masters.
- A certificate from the College Doctor or a registered medical practitioner must support requests for leave on medical grounds.
- Absentees on rejoining College must produce a letter from their parents or guardians explaining the cause of absence supported by a medical certificate in case of illness.
- ▲ If an appointment is made with a doctor, the student must not be sent to the College on that day.
- ▲ If a Scholar is absent for 10 days without prior permission,



his/her name will be struck off the rolls.

- ▲ Re-admission is at the discretion of the Principal.
- ▲ Fee of Rs. 2500/- must be paid in case re-admission is approved.



ANJUMAN BOARDING HOUSE

General

- ▲ The Boarding House is like life within an extended family for the Residents where the House Warden ensures their overall development.
- Life in a Boarding House provides a plethora of new experiences where the Residents make new friends and gain in confidence to become mature citizens of the world.
- ▲ Care is taken in the Boarding House for the growth and development of each Resident, within a certain framework of discipline, rules of conduct and behaviour.
- A Residents are allotted rooms/dormitories according to their age and class.
- ▲ Facilities for sports and games are available to all Residents.
- Recreational facilities like indoor games, television viewing and newspapers are also provided.
- ▲ Continuation as Residents is based on the academic performance, behaviour and turnout of the Students.
- In case of illness, Residents are admitted to the 16-bed College Infirmary. All cases of sickness are to be reported to the College Infirmary. Residents who are unwell are looked after by the trained medical staff. The Senior Medical Officer of Balrampur Hospital, Lucknow, visits the College Infirmary regularly. He is also available on call in case of an

emergency.

- If a Resident Scholar is already on medication, the House Master must be informed.
- New Residents should furnish a Medical Fitness Certificate.
- ▲ Summer and winter time tables for Residents have specified time slots for all activities. This schedule must be followed minutely.
- Wholesome, hygienic, nutritious vegetarian and nonvegetarian Indian meals are served as per the dietary preferences of the Residents. All Residents eat together under the supervision of the Boarding House staff.



NORMS OF THE BOARDING HOUSE





- ▲ The catering is under the direct control of the College.
- ▲ Birthdays falling during a month are celebrated together on one day of that month, with a special menu and a cake for all Residents.
- A Residents must bring clothing and other essential items as per the list provided by the College.
- All articles owned must be marked clearly with the Residents name in indelible ink.
- ▲ Though every care will be taken to prevent the loss of clothing and personal items, the College does not accept responsibility in this regard.

A torch with batteries, extra bed-sheets, ear plugs, swimming goggles, table tennis bats and badminton rackets may be brought by the Residents in addition to the list of stipulated articles.





DISCIPLINE

Discipline

- ▲ Residents cannot be in their rooms/dormitories during College hours.
- Residents are not permitted to visit or stay in any other rooms/dormitories but their own after 10:00 p.m.
- A Boarding House is out of bounds for the Day Scholars and the Resident Scholars are not allowed to call Day Scholars or outsiders to their rooms.
- All Residents shall be on the College playing fields at the time scheduled for games. Exemptions shall be made only for those who are ill. In such cases, a written permission must be obtained from the House Master, who shall consult the College Doctor immediately and make necessary arrangements for proper treatment and required medications.
- A Rooms and dormitories have to be kept neat and clean at all times. Weekly inspections shall be conducted. The Principal inspects the Boarding House regularly.
- Residents are expected to shave and have regular haircuts. Fancy hair cuts and coloring hair is prohibited.
- ▲ Resident Scholars must be punctual for all events.
- The use of electrical appliances such as heaters, electric irons, etc. is prohibited. If a Residents is found with such appliances, the items will be confiscated and disciplinary action will be initiated.
- A Gross violation of rules will result in the expulsion of a Residents from the Boarding House. In case the Principal deems appropriate, the Scholar may be expelled from the College as well. Grounds that may get a candidate expelled from the Boarding House and the College include but are not limited to:
 - ★ Using foul language
 - ★ Physical violence



- Residents are expected to use the study time profitably and strict silence has to be maintained in the study hall.
- ▲ Under no circumstances will meals be served in the rooms or dormitories.
- Residents are to report to the dining hall punctually and in proper dress. All meals are served after a short prayer.
- ▲ Only visitors authorised by the parents are allowed to meet the Residents.
- ▲ In case of an emergency, parents must contact the House Master.
- A Residents may use only button phones within the Boarding House compound. No multimedia enabled devices are allowed.
- ▲ Medical leave will be granted only by the Principal on the advice of the College Doctor or on receiving an application from the parents, duly endorsed by a competent medical authority and supported by prescriptions and medical bills.
- ▲ Sandals are not allowed. Rubber slippers may be worn in the rooms/dormitories only.
- ▲ The Residents must not have costly personal items on them or in the Boarding House.



FINANCIAL MANAGEMENT



Financial Management

- A Parents must open an account in the name of their ward at the Central Bank of India, and deposit money in that account.
- All incidental expenses of the Residents will be recovered from their account.
- All pocket money will be deposited with the House Master and any Residents found with over Rs. 500/- in their possession will face disciplinary action.
- Any Residents leaving the College in the middle of the

academic year has to pay the boarding fee for the entire year.

- Resident Scholars have to pay all dues to the College before leaving the Boarding House.
- ▲ In case of damage to Boarding House property, the defaulter will pay the full amount of the damage along with an additional penalty, which will be imposed on the recommendation of the House Master.
- As and when required, money will be given to the Resident Scholars and they will be expected to account for the same to the House Warden.
- A For specialized medical attention, specialists from the hospitals have to be consulted and paid. The expenses incurred in such treatments have to be borne by the parents or be deducted from the account of the Resident Scholar.



EXEAT RULES





Exeat Rules

- The House Master has the authority to decline the Residents request for leaving the College/Boarding House premises, without regard to the rules mentioned below, if he feels the security and safety of the Residents cannot be ensured.
- Residents are permitted to visit their local guardians after College hours on the last Saturdays of every month. They must return to the Boarding House the following Sunday before 5:30 p.m.

- A Residents are allowed out of the College premises on Sundays from 9:30 a.m. to 5:30 p.m. on the request of the parents.
- Visiting hours on Sundays and holidays are 9:30 a.m. to 5:30 p.m.
- A Parents are not permitted to visit the Boarding House on weekdays/working days.
- ▲ Resident Scholars of Classes III to X are not allowed out of the College premises unescorted.
- Resident Scholars must record the time of leaving and their return in the log register maintained at the Boarding House gate.
- Resident Scholars must leave the Boarding House during the summer, winter and other extended holidays.
- A Resident Scholars must return from their holidays on the stipulated date.
- A Parents must apply in writing to the House Warden if they wish their wards to travel alone.
- A fine of Rs. 200/- per day will be levied on Resident Scholars coming late after a holiday break.
- ▲ When visiting their wards, parents must first meet with the House Master. They must wait in the visitors' room to receive their wards. No parent is allowed in any room or dormitory.
